This policy is intended for all individuals who, after having purchased offline a Board Game made by Xplored for the Teburu platform, have downloaded the Game App, authenticating on it in the manner defined in Article 5 of the General Terms and Conditions ("Players" or "Interested Parties")

Art. 1 - Definitions

- 1.1 The terms referred to in this Cookie Policy are used in the meaning and according to the meaning attributed to them in accordance with Art. 3 of the General Conditions and ss.mm.ii., to be considered here fully referred to.

Art. 2 - Concept of cookie

- 2.1 Cookies are, as a rule, strings of text that the applications and/or the websites visited by a subject or the different sites/web servers (so-called "third parties") place and store - directly in the first case and indirectly (i.e. through the sites used by the individual) in the second case - within the device used by the individual for the browsing or the using of the application (such as, for example, computer, tablet, smartphone, etc.).
- 2.2 For the purposes of this Policy, the notion of cookies also includes similar technologies that allow, like cookies, and among other things, to facilitate the navigation of the Player through the Gaming App and to enjoy some particular functionality of the same.
- 2.3 The information encoded in cookies may include, therefore, both personal data - such as the Player's IP address and name, identity personal code or email address - and non-personal data - such as language settings or information about the type of device the individual is using to use the Gaming App.

Art. 3 - Classification of Cookies

- 3.1 The Gaming App uses the following cookies:
 - a) technical cookies, which are necessary to ensure that it works properly and can be either first-party (that is Xplored) or third-party cookies. Technical cookies are typically used to "carry out the transmission of a communication through an electronic communications network, or to the extent strictly necessary for the provider of an information society service explicitly requested by the contractor or by the user to provide such service." Also included in the notion of "technical cookies" are the "access cookies" better identified and regulated in Article 23 of the Privacy Policy;

- b) statistical or analytics cookies, which allow Xplored to collect anonymous, statistical and aggregate data about the use of the Game App, including analyzing the related traffic. The Player can disable such cookies by clicking here;
 - c) first-party cookies, used directly by Xplored as set forth in this Policy and the Privacy Policy;
- 3.2 Temporally, the cookies referred to in Art. 2.1 of above can be either so-called session cookies or permanent cookies, depending on whether they are deleted when the Game App is closed or they are stored on the Player's hard drive until their expiration.

Art. 4 - Management of cookie preferences

- 4.1 The detailed regulation of cookie discipline and preferences is contained in Chapter IV) of the Privacy Policy, to be considered here fully referred to.
- 4.2 Without any prejudice to the provisions of Art. 4.1 above, it is useful here to briefly recall that:
- a) the Player may set his or her own preference options regarding the use of the cookies described in Article 2 above, disabling those not liked;
 - b) the Player may register his/her preferences either at the first access to the Gaming App, using the so-called cookie banner, or later, by changing the preference choices already made in the dedicated area of the settings of the Gaming App;
 - c) the disabling of third-party cookies does not affect in any way the functionality of the Game App; on the other hand, the disabling of first-party cookies, especially technical cookies, could lead to malfunctions or limitations in the use of the Game App and its functionalities.
